Golf Cart Do's and Don'ts:

DO'S:

- **DO** read the Morehead City Ordinance Chapter 30 Article 9.
- **DO** comply with all traffic rules and regulations adopted by the state of North Carolina and Morehead City.
- **DO** have all safety features required for golf cart operation.
- **DO** have a valid driver's license and be at least 18 years of age to operate a golf cart.
- **DO renew golf cart permit each calendar year between January 1st and March 31st.**
- **DO** watch your speed- maximum speed for golf carts is 20 mph.
- **DO** display golf cart permit in a visible location on the back of the vehicle.
- **DO** have the operator and all passengers wear seatbelts in accordance with state law.
- **DO** use child safety seats, as necessary, in accordance with state law.
- **DO** cross a road with a posted speed limit greater than 25 mph only at traffic light controlled intersections.

DON'TS:

- **DO NOT** operate a golf cart while under the influence of any impairing substance or have an open container or beverage of alcohol on the golf cart.
- **DO NOT** operate **or** park golf cart on sidewalks or bicycle paths.
- **DO NOT operate golf cart on any public street with a posted speed limit greater than 25 mph.**
- **DO NOT** allow the number of people in the golf cart to exceed the maximum capacity specified by the manufacturer.
- **DO NOT** allow passengers to ride on any part of a golf cart not designed to carry passengers, such as the part of the golf cart designed to carry golf bags.
- **DO NOT** use golf cart to tow another cart, trailer or vehicle of any kind, including any person on roller skates, skateboard or bicycle.

I certify, under risk of forfeiture of privilege and/or payment of penalty fees, that I have received a copy of the Golf Cart Ordinance and Regulations and that I have read, understand, and agree to strictly adhere to all rules and regulations set forth and pertaining to the operation of golf carts within Morehead City. I understand that I am responsible for all golf cart operators and passengers whether I am present or not.
